- O The roles of state and non-state actor initiatives, international organizations (including the UN system and IAP2) and other parties in facilitating the institutionalization of P2 and SE, such as IAP2 Core Values in action.

IAP2 Core Values:

- People affected by a decision have a right to be involved in the decision-making process.
- People will be informed how their contribution influences the decision.
- The needs and interests of all people, including decision makers are recognized.
- People affected by or interested in a decision will be sought out and their involvement facilitated.
- People assist in designing how they participate.
- People are provided with all the information they need.
- People are informed about how their input affects the decision.

The 2030 Agenda for Sustainable Development sets out seventeen ambitious sustainable development goals (SDGs) for the international community. The Asia-Pacific region continues to experience rapid development and increasingly becomes a hub for a progressively globalized economy. Despite the significant economic growth and expansion within the region, there are still substantial challenges to achieving the SDGs including income and social inequality, a growing gap between rich and poor, continuing environmental degradation, and declining civic space.

The 2030 Agenda for Sustainable **Development demands** increasing participation of the public and stakeholders in development processes, in particular through the emphasis on inclusive decision-making and effective institutions in Goal 16 on Peace, Justice, and Strong Institutions. Public participation (public-initiated engagement) and stakeholder engagement (government or institution-led) are requirements for social accountability and strengthened governance. The topic will receive special attention in the various UN-related arenas this year, with governments agreeing to address "empowering people and ensuring inclusiveness and equality" as theme of the High-Level Political Forum. The evidence is mounting that engaging people in policy and decision-making processes leads to more efficient and effective public service delivery in health, education, infrastructure, and other areas. Engaging diverse

views and perspectives of stakeholders, communities and the public generates more environmentally, economically and socially-sustainable decisions. For this reason, public participation and stakeholder engagement are increasingly seen as an integral part of the day to day work of government business.

However, the experiences of effective public participation and stakeholder engagement in developing countries are limited and under-documented. The challenge is to increase access and awareness of the evidence-based research public participation in developing country contexts, and bringing this to bear on government policy and practice at all levels of governance.

The International Association for Public Participation (IAP2) will organize a Forum during April 29 -May 1, in Bangkok, Thailand in the context of its mandate to advance the practice of public participation and to strengthen capacity for stakeholder engagement across the globe. In executing the event, the International Association for Public Participation (IAP2) will partner, the School of Government and Public Policy (SGPP) and the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP), building on IAP2's partnership with UNESCAP to promote public participation, and stakeholder and community engagement as a means of strengthening the implementation of the 2030 Agenda.

Dates and location:

This two and a half-day forum will be held from April 29 - May 1, 2019 at the United Nations Conference Centre in Bangkok, Thailand.

Day 1. Presentation of research papers, policy and advocacy experiences in interactive sessions/marketplace approach – based on a call for papers.

Day 2. Workshop for sharing the insights from the first day, and discussing the implications for public policy and future research agenda in specific areas around of Public Participation (P2) and Stakeholder Engagement (SE).

Day 3. (1/2 day) Partnership dialogue involving organizational stakeholders (including from IAP2, UNESCAP, SGPP, and other partners) are to share initiatives and plans, as well as to discuss potential co-investment and follow up.
