

St Vrain Valley School District discovers a large budget shortfall





### **Public Participation Challenges**

- conflict-driven media
- heavy reliance on "experts"
- polarized ideological interests
- history of "decide, announce & defend" tactics
- rising distrust for institutions and government
- lack of P2 values in popular culture

Needed knowledge and trust of community





### **IAP2** Core Values

#### **Public Participation in Decision Making**

The Board of Education endorses the concept that public participation in the affairs of the schools is essential if the school system and the community are to maintain mutual confidence and respect and work together to improve the academic achievement of students in the district. It therefore intends to take steps to identify the desires and concerns of the community and be responsive, through its actions, to those desires and concerns.

All citizens of the district are encouraged to express their ideas, concerns and judgments about the schools through such means as written suggestions or proposals; presentations at hearings; responses to surveys made through interviews, written instruments or other means; comments at meetings of the Board; service on citizens' advisory committees; participation in focus groups and involvement in community engagement and deliberative problem-solving processes.

The advice and concerns expressed by the school community will be given careful consideration. In the evaluation of such input, the first concern will be for the educational program as it affects students. The Board's final decision may depart from the views expressed by some members of the school community when in the judgment of the Board such views are not consistent with good educational practice or within reach of available financial resources.

### The academic achievement and success of our students

- Over the past 9 years, St. Vrain students have continued to deliver:
  - An upward trend in standardized test scores
  - Increased graduation percentages
  - Decreased numbers of students dropping out
  - Increased scholarship awards for students
- 78% of St. Vrain's 52 schools are accredited with Distinction or Performance
- Over 50% of secondary students currently take one or more advanced level course(s)
- District ACT scores are above the state average in every content area

#### **Leadership St. Vrain**
